


## HONGKONGAS ANINTERNATIONAL FINANCIALŒNTRE

However along with the additional funding, the company would be exposed to the ever-changing and stringent compliance requirements, whether it is the Securities and Futures Ordinance, the Listing Rules, the Laws of Hong Kong or the respective jurisdictions, or the Hong Kong Code on Takeovers and Mergers.

#### **Basic Filings**

As bound by the Companies Ordinance, listed companies in Hong Kong similar to Hong Kong private companies, are exposed to continual reporting obligations to filing of returns with regulatory bodies and governmental bodies in Hong Kong.



Our company secretarial services for basic filings requirements include:

- Preparation and filing of monthly return to the Stock Exchange
- Preparation and filing of statutory returns to the Companies Registry

#### **Interval Reports and Other Ongoing Maintenance**

As required by the Listing Rules, Main Board listed companies are required to annual results within 3 and 4 months after the period/year ends respectively. While GEM listed companies are required to release their quarterly and interim reports and results within 45 days after the period ends and 3 months after their financial year ends.

In assisting our clients to ensuring full compliance with the increasingly complex rules and disclosure requirements, while meeting the stringent deadlines upheld by the Stock Exchange, and still acting within their budgets, our company secretarial services for financial reports include:

- Preparation and publication of annual, interim and quarterly results announcements and reports
- Preparation of circulars and public announcements
- Share repurchase and issuance mandates
- Liaison with the Hong Kong Stock Exchange and regulatory bodies on disclosure requirements
- Convening, facilitating and attending board and general meetings and preparation of chairman's scripts and minutes thereof

BMICS's quoted fees for private companies are inclusive of all local registered agent costs and government charges. Out of pocket expenses are charged separately and would be principally client communication costs. Material extra costs such as expenses for obtaining legal opinion are always agreed with clients before being incurred.

When requesting a fee quotation for company or trust formation, clients should indicate the preferred domicile, whether nominee services are to be provided and the scope of any additional services required such as the opening of bank accounts or the preparation of powers of attorney.

Clients should note that in order to maintain companies in good standing, it is important to pay fees promptly since in all jurisdictions, failure to settle government charges on time will usually result in penalties being levied or in the company being struck off. Penalties and/or the costs of reinstating companies can be substantial. BMICS will normally notify clients in advance of renewal fees becoming due. In general, all other types of work undertaken are charged accordingly to time spent and the level of skills and responsibilities involved and are subject to agreement with clients.
